b) Give a suggestion on how you can teach young Rwandans to respect personal choice and diversity. **(3marks)**
- 4) Bill Gates, the founder of Microsoft, is one of the richest men in the world. Bill and Melinda Gates have two daughters and one son. Bill Gates has gone on record saying that each of his three children will inherit 10 million United States Dollars. That might sound like a lot of money but actually, it is a small amount compared to the Gates' multi-billion dollar fortune. The rest of the money will be given to charitable organisations.

a) Suggest a reason that prompted Bill Gates and his wife to limit their children on their fortune/inheritance. **(1mark)**

b) Do you think it is important for Bill Gates' children to choose a career in their life? Support your answer. **(3marks)**

- 6) My friend has told me that his mother's monthly income is 800,000Frw. Basing on individual monthly tax rates in Rwanda, calculate his mother's monthly tax. **(5marks)**
- 7) Suppose you are an Executive Secretary of Rwanda Revenue Authority and you are in the "umuganda" with your neighbours, explain to them the following statement: 'Without taxes there is no peace, no roads, no hospitals and no schools'. **(5marks)**

- 8) Differentiate PIN from TIN and explain their importance to Rwandans. **(4marks)**
- 9) Draw a voucher that you can use in any business. **(5marks)**
- 10) Mugisha runs a new bakery business for making different cakes where she has the capacity to make 10,000 cakes per month.
As an inspector of Rwanda Standards Board, explain why you would carry out the quality test of those cakes. **(6marks)**
- 11) Umulisa is a matron in one secondary school in Rwanda. However, all students of this school disagree with her. Convince her on how she can resolve conflicts with those students. **(4marks)**
